SUBMISSION GUIDELINES

We invite authors to submit their abstracts for the 10th Pan IIM World Management Conference in accordance with the following guidelines:

- **Format:** Abstract submissions (not more than 250 words) must be a single document in either PDF (.pdf) or Word (.doc, .docx) format.
- **Font:** Times New Roman
- **Font Size:** 12
- **Line Spacing:** Double-spaced
- **Margins:** Maintain a 1-inch (2.5 cm) margin on all sides.
- **References:** Include a complete list of references at the end of the document, formatted according to the APA Style Guide (7th Edition).
